Epok Tread 9015 Aggregate to be applied lightly and evenly sprinkling the granules vertically on to the freshly applied Epok Tread 9015 Screed Compound. After full cure excess Aggregate should be swept off the surface, may be re-used if dry and uncontaminated.

#### Overcoating

Apply a sealer coat of Epok Tread 5107 Finish in accordance with specific Product Data/Application Instructions.
